SUBJECT: Statewide Information Technology (IT) Policy and Adoption of NIST Frameworks

This memorandum informs you of updates to IT Policy creation and adoption of National Institute of Standards and Technology (NIST) Special Publications and Frameworks. Statewide IT Policy will align to NIST Frameworks and best practices. The baseline security and privacy controls apply to all State of Alabama Executive Branch departments, agencies, offices, boards, commissions, bureaus, authorities (agency or agencies) and authorized individuals engaged in State IT responsible for the management, operation, or use of IT resources, including contractors and retired state employees. Vendors, suppliers, resellers, or any entity conducting IT work or business with the State will follow IT Policy.

The State adopts and adheres to IT Policy the following as statewide IT security frameworks:

1. NIST Special Publication (SP) 800-37 Rev. 2 – Risk Management Framework (RMF) for Information Systems and Organizations or its latest version as the standard for managing State information security risk and maximizes the State's functionality, security, and interoperability of distributed IT assets, including data classification and management, communications, and encryption technologies.
2. NIST SP 800-53 Rev. 5 – Security and Privacy Controls for Information Systems and Organizations or its latest version as the framework for the Statewide Risk Management Program and alignment of its IT security policies. The State may modify certain controls from NIST 800-53 requirements when deemed necessary. NIST SP 800-53 Rev. 5 provides a solid risk management foundation for organizations to secure their information systems.
3. NIST Artificial Intelligence (AI) RMF 1.0 or its latest version as the applicable standard risk-based approach to control selection and specification of new or legacy systems or technologies (e.g., IoT, control systems) and integrate security, privacy, and supply chain risk management activities into system development life cycles. Agencies accept all risks associated with their use of AI, including AI use that results in negative financial impacts involving data loss, improper data usage, unintended changes to existing processes and code, or security vulnerabilities.

The statewide IT security frameworks provide a structured path to categorize systems, select and implement security and privacy controls that meet mission and business needs, track control effectiveness, and authorize and monitor systems for operation. Implementing trustworthy, robust, and comprehensive information security and privacy risk management programs facilitates compliance with applicable laws, regulations, executive orders, and governmentwide policies. The adoption of NIST frameworks also allows for a controls-based mapping crosswalk to common security frameworks as may be required by State, Federal, and industry partners.
